

TERMS AND CONDITIONS

WELCOME TO SSAA VICTORIA ONLINE SHOP

1. WHO WE ARE:

- 1.1. SSAA Victoria is an online shop where you can purchase products from time to time by entering your details in the form and clicking on the button that says "Place Order".
- 1.2. SSAA Victoria website is owned, operated and maintained by Sporting Shooters Association of Australia (Victoria) Ltd. ACN 005 020 422 ("SSAA Victoria") of Unit 3, 26 Ellingworth Parade, Box Hill Victoria Australia (ph) +61 3 8892 2777 (email) state_office@ssaavic.com.au.

2. ABOUT THE AGREEMENT:

- 2.1. To make this Agreement easier to read, we have defined certain words and phrases and capitalised them throughout this document. Definitions of those words can be found at the end of these terms and conditions.
- 2.2. Use of some parts or features of the website may be governed by other terms and conditions. Those terms and conditions will also apply to this Agreement and will prevail over this Agreement if there is any inconsistency between them.
- 2.3. We may amend this Agreement at any time without notice. Any amendments to this Agreement will be effective as soon as they are posted to the website. By using this website, you agree to be bound by any changes to this Agreement.

3. HOW YOU ORDER:

- 3.1. By clicking on the "Place Order" you are agreeing to the following:
 - a. You are offering to purchase a product for the price advertised at the time of your purchase on SSAA Victoria.
 - b. You have the intention of being legally bound, upon our acceptance of your offer.
 - c. You are over the age of 18 years or have the permission of an adult to do so.
 - d. You have read and understood the terms and conditions of this Agreement.
 - e. Your name, phone number, address and email address will be added to our database for the purpose of subscribing you to our newsletter (at no cost). Our newsletters may include special offers or incentives from us or our selected partners. Please view our Privacy Policy for what we do with your information. Every email newsletter you will receive will have an opt-out provision allowing you to stop receiving any future promotional communications. To opt out from our newsletter follow the unsubscribe link in the footer of the email.
 - f. You authorise us, our financial institution, and our bill payment systems provider to deal with your credit or debit card in order to process your information for the purposes of payment to us for the purchase of products.
- 3.2. Once your offer to purchase a product is made, you will receive an email from us summarising and confirming receipt of your order.
- 3.3. The agreement to supply you on the terms of your offer will be complete upon dispatch to you of the product being purchased. Until that time, we reserve the right to reject the order, because of unforeseen difficulties with supplying the product, including of availability or a system error. In these circumstances, we will provide a full and timely refund.

4. PRICES:

- 4.1. Prices are as follows:
 - a. Prices for products sold exclusively within Australia are advertised in Australian dollars and are GST inclusive but have a delivery cost added to the final price. The delivery cost will be calculated at the end of your order and will be dependent on your location.
- 4.2. No items sent by post or courier have any insurance coverage included in the purchase price including loss or damage to an item.
- 4.3. Payment is to be made in Australian dollars.
- 4.4. SSAA Victoria will not be held liable for any loss due to you entering incorrect details on the form, including but not limited to an incorrect address provided by you. In the event that you change your address between the time you purchase a product, you must notify SSAA Victoria in writing of your change of address. You can contact SSAA Victoria for more details on 03 8892 2777.

5. PRODUCT DISPATCH:

- 5.1. Products will be delivered to you within 1 to 2 weeks of your order.
- 5.2. In the event a delivery is delayed, we will inform you of this and provide you with the option to either wait giving you an approximate wait time, choose a different product of equivalent value or refund your money.

6. 10 DAY CHANGE OF MIND GUARANTEE:

- 6.1. Products returned for change of mind can be returned for a store credit note. A refund is not available for change of mind.
- 6.2. You may return your product for change of mind within 10 days of us dispatching your purchase to you.
- 6.3. This policy does not apply if you believe your products are faulty or are not what you ordered. Our faulty product return policy appears below instead.
- 6.4. Returns for change of mind must be returned in the original unopened packaging, and the packaging must not be damaged.
- 6.5. Returns for change of mind will be credited in the amount you paid for the product, less any initial delivery charges as set out in your Order Confirmation email.
- 6.6. Store purchases must be returned to the store with your proof of purchase.
- 6.7. Online purchases must be returned to the following location with evidence of your proof of purchase:

- 6.8. In order to obtain a store credit note for change of mind, you must first return the product(s) at your own cost. Under no circumstances will we issue a credit note before we have received your product back to our premises and checked it as being in the original unopened and undamaged packaging.

7. RETURNS POLICY

7.1. WARRANTY PERIOD:

SSAA Victoria offers this voluntary 12-month warranty from date of purchase against manufacturing defects in products supplied by it. Any products supplied by third parties are subject to the warranty terms of the supplier.

7.2. WHAT DOES THE WARRANTY COVER?

Under normal usage conditions, this warranty covers;

1. Any defect in design or manufacture which results in the product failing to perform substantially as described in authorised advertising or literature; and
2. We will either repair or replace the product at our discretion

This voluntary warranty is provided in addition to your other rights and remedies under the Australian Consumer Law and does not exclude, restrict, modify, limit or override your rights under the Australian Consumer Law.

7.3. THE WARRANTY DOES NOT COVER:

1. Damage resulting from improper use
2. Damage caused by faulty installation or modification made during installation, unless installed by SSAA Victoria
3. Damage caused by mould, insects, animals, misuse, incorrect operation, adverse weather, accidents and fair wear and tear
4. Costs, losses or charges:
 - of removing and reinstalling the product;
 - for travel and /or other expenses due to customer's remote location;
 - for transport charges and damage in transit. It is your responsibility to deliver and pick up your product, including any costs associated with the postage of your repair or replacement product. If you do freight your product, we recommend that you insure against loss or damage;
 - directly or indirectly associated with the product failing to operate.

7.4. IMPORTANT INFORMATION RELATING TO YOUR RIGHTS UNDER AUSTRALIAN CONSUMER LAW:

Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality, and the failure does not amount to a major failure.

7.5. HOW TO CLAIM:

To make a claim, email state_office@ssaavic.com.au or call 03 8892 2777. Please retain your proof of purchase to assist with your warranty claim.

PLEASE NOTE: NO CASH REFUNDS WILL BE PROCESSED AT OUR RANGES. ALL FAULTY ITEMS NEED TO BE ASSESSED BY OUR WARRANTY DEPARTMENT BEFORE YOUR CLAIM IS FINALISED.

7.6. FAULTY PRODUCT RETURN POLICY:

Under the Australian Consumer Law, you can choose a refund or exchange if an item has a major problem. This is when the item:

- has a problem that would have stopped someone from buying the item if they had known about it;
- is unsafe;
- is significantly different from the sample or description; or
- doesn't do what we said it would or what you asked for and can't be easily fixed.

Alternatively, you can choose to keep the item, and we will compensate you for any drop in value. If the problem is not major, we will repair the item within a reasonable time. If it is not repaired in a reasonable time you can choose a refund or replacement.

Please keep your proof of purchase - e.g. your receipt.

8. DISPATCHED GOODS NOT RECEIVED:

In the event that you do not receive dispatched products and we are unable to assist you in locating them in transit, we will require you to provide us with a Statutory Declaration witnessed by an eligible person and setting out that you have not received your product before we will consider replacing a product lost in transit. We have the sole discretion to refuse to replace a product lost in transit.

9. STATUTORY GUARANTEES:

Purchases from this website are subject to the Australian Consumer Law and the statutory guarantees contained in it.

10. PROTECTING YOUR PRIVACY:

The website has a [Privacy Policy](#) that applies to all Users and is incorporated into this Agreement. You should read the [Privacy Policy](#) before making purchases through the website.

11. USE OF THE WEBSITE:

11.1. You may not use the website in any manner or for any purpose that is unlawful, that violates any right of SSAA Victoria or any other person, or that is prohibited by this Agreement. In particular, but without limitation, it is a condition of your use of and/or access to the website that you do NOT do any of the following:

- a. use the website for commercial purposes beyond making a purchase from our website;

 - d. does not promote any criminal activity or enterprise, including but not limited to inciting an act of terrorism, buying or making weapons, or violating someone's privacy;
 - e. does not violate any Applicable Law; and
 - f. will not create liability for SSAA Victoria or cause us to lose (in whole or in part) the services of our internet service providers or other suppliers.

12. YOUR INFORMATION:

- 12.1. Subject to our obligations under the Privacy Act, SSAA Victoria does not accept responsibility for Your Information. Your information is used in accordance with and for the purposes set out in this Agreement and our Privacy Policy.
- 12.2. You must promptly inform us if you become aware that any of Your Information breaches this Agreement and take whatever steps may be necessary to correct the breach. This clause is not intended to limit our rights under any other provision of this Agreement if such a breach occurs.
- 12.3. In order to protect your security, we encourage you not to include any personal information that makes you readily identifiable to other Users. In addition, you should never share information such as your telephone number, home address or credit information with other Users.

13. OTHER INFORMATION:

- 13.1. We do not check and do not take responsibility for:
- a. The veracity, accuracy or completeness of information provided by you on or in connection with the website (including the identity, age or place of residence); or
 - b. Content on this website which we source from Third Party Websites.

14. DELIVERY FEES:

Your delivery fee will vary depending on the size, weight and location of the products you choose to purchase as well as your chosen delivery location. Your delivery fee will be calculated and displayed when you checkout before you purchase your products.

Products will not be delivered to an unattended address. The courier will require a signature from the purchaser or authorised person at the specified delivery address at the time of delivery. If no one is available to sign for any parcel, a card will be left, and the parcel re-directed to the nearest Courier depot. It will then be the responsibility of the purchaser to collect the goods from the designated depot or to arrange re-delivery at their expense.

SSAA Victoria recommends all deliveries be shipped to an address that is attended during business hours, whether that is a home, work or other address, to minimise any re-delivery delays and/or fees.

15. P.O. BOXES AND PARCEL LOCKERS:

Except for gift cards and range passes, couriers we use will not deliver to P.O. boxes or Parcel Lockers (unless specifically arranged by you through your AusPost eParcel account (applicable to AusPost deliveries ONLY, additional charges may apply)).

Please ensure a full address is entered in the checkout process.

16. INTERNATIONAL SHIPPING:

Unfortunately, SSAA Victoria will not ship internationally at this time.

17. FREIGHT-INCLUDED PRICING:

From time-to-time SSAA Victoria will offer freight/delivery/P&H-included pricing on specified products to Australian addresses. 'Incl Freight', 'Incl Delivery' and Postage & Handling promotions do not apply to all areas. Check your suburb and postcode below to confirm if your location is included in Freight promotions.

Freight charges apply to some areas for product purchases and occasional promotions.

18. INTELLECTUAL PROPERTY:
